Entry Fee is \$60.00 (All State Level Pageants' Fees are the Same Amount.)

- Must be an Oldham County Resident. You may attend a private school outside Oldham County, but MUST live inside Oldham County perimeters (verification with drivers license, mail, or utility bill and school verification with report card or similar)
➤ You may register in person or by mail. Late Registration begins on July 21st through July 25th. There will not be any entries accepted after July 25th. Registration is at the fairgrounds in the Pageant Building , 10 am -4 pm weekends.
➤ Entry fee, Bio, Entry Form, Proof of Residence, Picture, Birth Records, School Verification, Permission Form, and Winner's Agreement Form must all be completed at registration in order to be valid and approved for competition. If not, the Deadline Dates will apply along with the added Late Fee. If all forms are not signed and turned in before July 25th, the contestant will not be allowed to participate.
➤ Late Registration will be an additional fee of \$25.00. After July 28th, the deadline for entry, there will be no entries accepted. No Exceptions. If you registered late and have missed practices, it will be the contestant's responsibility to catch up on the instructions, dance routine, and all other aspects of the pageant they have missed without help from either staff or contestants while or during pageant practice times. You will have to catch up on your own time. But I'm sure there will be people to help you in that case!
➤ You may mail completed and signed registration forms along with requested forms and fee prior to registration day to: Sondra Cawthon, Pageant Director, OC Fair, PO Box 193, Lagrange, KY 40031 (NOTE: Mailed forms also are subject to deadline dates. They MUST arrive no later than July 25th and MUST be complete.) NO EXCEPTIONS.
➤ There will be NO using the stage for practices by individuals, or groups of individuals, except at scheduled practice times. This rule applies to make it fair and equal for every contestant participating in that pageant. Practice times will be scheduled and everyone must abide by this same rule.
